
God bless our troops, God bless all of you and may God always bless America. Come out and see us.

Just One Idea for the VA

Quality control and case management: Much is made of the VA's perpetual handicap of a partial paper-based system and partial computer-based system. Big deal. Your favorite federal agency and mine, the Internal Revenue Service, had a half-paper and half-computer based processing system which worked fine thirty-five years ago! Let's be specific: Tax Auditors with 12 semester hours in accounting (number crunchers) did individual and small business tax audits, Revenue Agents with accounting degrees (bigger number crunchers) did corporation audits, Revenue Officers with 6 hours of accounting (people meeters and dealers) collected from those individuals or corporations who owed and chose not to pay when they could.

Now to quality control – the biggest problem with the current VA adjudication "system": Each function within the Examination division in each district (Indiana is one district) had a Review Staff which randomly sampled audits before they were sent out. Review Staff was filled by rotational assignments of the best employees in each sub-function. When Review Staff found a processing error, which they really tried to do, they sent the case back to the originating examiner to fix. When the examiner had a few cases returned on the same issue, that examiner was retrained or, if retraining did not work, removed. Honest. Union grievances could not reverse removals based on empirical quality data comparing the occupational specialty norm to the individual employee's performance. On a more positive note, employees who seldom, if ever, received cases back from Review Staff received incentive awards. Also, standard training and Review Staff sampling were adjusted according to feedback from Review Staff findings. Worked great! Made the IRS look, if not good, at least more professional and much less time was lost in appeals because almost all the work was being done right the first time.

Case management? At each step of processing the work time applied to each case was electronically charged to that case. If auditor Jones was using more than the normal time on an individual taxpayer audit, he could explain the unusual complexity of the case to his boss – a boss who had been an auditor herself in the past and who could understand (she just left Review Staff) and approve or disapprove the increase. If auditor Smith screwed up and a case slipped by Review Staff sampling and got out and resulted in an appeal, a bunch of IRS time would be charged to that case and it would stick out like a sore thumb in the electronic workload data, crying out for "Don't ever do this again!" training or other management action. (IRS hates to lose appeals or court cases. Losing is not the voluntary compliance enhancing word the IRS wants on the street.

How I wish the VA would learn from their mistakes as well as the IRS does from theirs.)—Wouldn't you like to see

the VA do these Review Staff and time-charged-to-each-case things?

Fix: Look outside the VA for management ideas such as the IRS Review Staff and the charged time to each case workload management system. The same VA analyst employees who have been pondering their internal problems for decades will continue to come up with the same internally pondered "solutions" and disguise them as new. Secretary Shinseki, it's been three years now. Let's see some improvement.

Court to Decide on Stolen Valor Act

The Supreme Court of the United States to hear the case of *Unites States vs. Alvarez* in 2012. The case will determine the "right" of veteran impostors to lie about military service with legal impunity. The case centers around the First Amendment to the United States Constitution and the and integrity of the 2006 Stolen Valor Act, which makes it a crime to pretend to have been awarded any decoration or medal authorized by the US Congress for the Armed Forces of the United States.

Opponents of the act claim "white lies, exaggerations, and deceptions are in integral part of human intercourse" and "harm no one". In short they say, lying is protected as free speech under the First Amendment.

Critics counter that false statements are not entitled to such protection. The **Stolen Valor Act**, they say, "serves a crucial purpose in safeguarding the military honors system".

<u>Military One Source</u> will once again provide free tax consultation and free on-line tax filing services to military service members and their families during the tax season. As in previous years, participants will have free online access to the H&R Block At Home Basic tax product.

A brief overview of the program:

- Participants must register for Military OneSource and log on to the site for access to the H&R Block At Home Basic product. A separate logon for the H&R Block At Home site is required.
- Those eligible for the program are active duty, Guard and Reserve (regardless of activation status), spouses and dependent children (authorized in DEERS), family members handling the affairs of a deployed service member, and severely injured service members or family members handling their affairs.
- Participants will have free access to the H&R Block At Home Basic product. Those with more complicated returns may incur charges if they upgrade to the H&R Block At Home Premium product.
- Participants can file up to three state resident returns for each federal return that they file with the H&R Block At Home Basic product.
- Participants can speak with a Military OneSource Tax Consultant if they have tax related questions, or need assistance using the H&R Block At Home Basic product.


