Golf Balls for the Troops

VFW members Kenny Strong, Fred Jones and Clint Strong collectively donated over 13,000 golf balls, 150 golf clubs, and 3 Golf Bags to be sent to troops serving our great nation. As with the movies donated a few months ago by Yellow Cab owner John McNeely, VFW Post 604 was asked to assist in coordinating the logistics in this effort. Arrangements were made and all material was picked up from Post 604 by the National Guard on Wednesday February 07, 2012.

Our thanks are extended to these VFW Members for their generosity in putting the welfare and recreation of our deployed forces on such a high pedestal. We're sure the troops in Afghanistan will enjoy knocking them around.



Another VA Problem and Recommended Fix

"Regionalization": The VA takes basic compensation and pension claims and sends them to designated regional offices for portions of the United States. The Milwaukee RO is the central processing regional office for service connected death and pension claims originating in Indiana. Again, the most observable result is balancing out the backlog which, overall, accomplishes zilch. The best regional offices are punished instead of the worst being fixed.

There are two more curses of this practice:

- First, say Ellettsville, Indiana widow Gertz (fake name, real case) wants a personal hearing in conjunction with her appeal of a Milwaukee Regional Office denial? The lady who just lost her husband after years of his declining health due to Agent Orange poisoning, she gave him years of home care, the VA has just denied her service connected death claim (erroneously, it turns out the denial was reversed on appeal), she lives by herself because her kids are grown and have moved away, now she gets to find and fund her own way to Milwaukee, Wisconsin for her personal hearing? We firmly requested a personal hearing in Indy. Even when such a change of hearing location is granted, the Indy people are not familiar with Milwaukee cases and have to learn them from scratch. Not efficient or effective.
- 2. Second, Milwaukee VA employees are not familiar with Indiana crooks. There are several firms which encourage gullible veterans to file fraudulent pension claims, e.g., "Get your \$1,644 per month A&A now! \$1,949 if you're married! Fill out our special forms! Have our contract doctor state you must have your medications administered! Maintain your active life style here in our retirement community!" Bear in mind that "Aid and Attendance" means that the individual whose severe medical condition is so categorized requires the aid and attendance of others in order to live – such as a patient in a nursing home. A&A qualification is inherently incompatible with "active life style, independent living". Indianapolis VA employees were about to get a handle on

these firms when the Indiana pension cases were routed to Milwaukee. Milwaukee VA employees don't know beans about Indiana crooks, and probably have no reason to care. They just want to get those cases off their desks. Again, your taxpayer dollars down the tubes AND, in the unlikely event a few of these fraudulent claims are actually discovered, guess who would be "left holding the (overpayment debt) bag"? The gullible veterans who signed the claims and were improperly paid the benefits!

Fix: Forget "regionalized" (centralized by regions) claims processing. Indianapolis VA employees need to process, and take pride in processing, claims from Indiana veterans, Indiana surviving spouses, and Indiana dependent children. Indiana claimants and their representatives need the easiest/closest access to their respective claim folders. Indianapolis VA employees need the chance to learn and deal with the Indiana crooks and scams. Indiana appellants need an easier/closer personal hearing location for their unreimbursed travel.
