## Indiana Skool Benefit

When I first heard about the Indiana "Child of Disabled Veteran" (CDV) award, also known as Remission of Fees, in the 1970s it was pretty simple. The child of an Indiana veteran who had wartime active duty service and a service connected disability recognized as such by the Veterans Administration was entitled to a (from the perspective of the child) significant discount on his or her tuition to any state supported college/university up to 124 semester hours. There were clarification issues, such as were adopted children eligible (if adopted before age 24), would the child of a veteran who entered active duty from Indiana but currently lives in another state be eligible (Vet just had to live in Indiana for 36 consecutive months during his or her lifetime), was there a minimum percentage for the service connected total rating (no, a zero percent rating would qualify), was there an age limit for the child (no), and did the child have to be a resident of Indiana (for one year prior). Parallel bases for eligibility were a parent being a Purple Heart recipient or former POW

The above description was accurate from the perspective of the student applying for the benefit but behind the scenes Indiana money was actually changing hands. The tuition was not just reduced – the amount of reduction varied from school to school – the schools were being reimbursed for their respective shortfalls by the state. This complexity, difficulty in budgeting for reimbursement expenses, and student and parent complaints based on the different schools having different amounts of tuition reduction ended with an Indiana court decision in 1999. Summary: ALL tuition and mandatory fees up through 124 semester hours would be covered at the undergraduate rate for ALL state supported schools. The application form also changed to ask the applicant which school they planned to attend and when.

Our Man Mitch came to office and sent staffers out to find ways to reduce Indiana government expenses. The CDV bill which passed both houses and awaited Daniels' signature stopped eligibility for children of the zero percentage service connected disabled veterans and pro-rated the state reimbursement according to the percentage of disability. Only the children of 100% service connected disabled veterans or of a veteran who died a service connected death were eligible for the 100% reimbursement, e.g., a child of a 50% disabled veteran would receive a 50% reduction. Requirements for a lived-in-Indiana-before-entering-active-duty and had-wartime-service veteran and Indiana-resident student applicant remained as did eligibility based on a Purple Heart recipient or POW parent. But the bill did expand remission of fees eligibility to include the Purple Heart recipients themselves and not just their children.

Veterans of Foreign Wars, American Legion, other military service organizations, and many others were not happy. Many disabled veteran parents had based their financial planning for their children's education based on the CDV/Remission of Fees benefits in their pre-Daniels form. One issue was the sudden loss of eligibility for the children of "the zero percenters". Another was the dramatic reduction of reimbursement for children of veterans rated at the lower end of the percentage scale, such as 10% or 20%. Veterans service organizations have legislative clout based on votes. The Daniels administration stopped to reconsider.

Here we are today with the resulting compromise, a two-tiered program. The program as it was, with very few changes,

is still in effect for the children of veterans who first entered active duty before 30 June 2011. Children of veterans who first entered active duty on or after 1 July 2011 are covered by the new program. Here's an excerpt from the "disabled veteran entered on 1 July 2011 or after" program pertaining to tuition reimbursement rates:

- the eligible applicant is entitled to a reduction in the educational costs that would otherwise apply as follows:
  - (1) If the individual's father or mother suffered a disability as determined by the United States Department of Veterans Affairs with a rating of eighty percent (80%) or more, the individual is entitled to a one hundred percent (100%) reduction in education costs.
  - (2) If the individual's father or mother suffered a disability as determined by the United States Department of Veterans Affairs with a rating of less than eighty percent (80%), the individual is entitled to a reduction in education costs equal to the sum of:
    - (A) twenty percent (20%); plus
    - (B) the disability rating of the individual's father or mother.

You'll notice the original Daniels "takes 100% to get 100%" was changed to 80% and up. It also can be read that a zero percent service connected rating would result in a 20% remission of fees, i.e., 20% is the floor of eligibility if one of the student's parents had wartime service and any service connected disability. (As with any state or federal VA benefit, when in doubt apply. The school's veterans affairs and financial aid offices can advise and assist.) The new program added grade point average and maximum age requirements (sufficient to show progress and less than 32 when enrolling) upon the students, a five year Indiana residency requirement for the veterans prior to their entering active duty, and other restrictions too numerous to list here.

The Indiana Department of Veterans Affairs stopped accepting the former CDV/Remission of Fees application State Form 20234 (R16 / 4-08) on 1 November 2017. Student applicants now must apply online through <https://scholartrack.in.gov> and "All students must upload a copy of their birth certificate or adoption papers with their online application." (I tried to work my way through the "scholartrack" system in order to describe the process but it locked up somewhere after I entered my high school graduation year. I didn't get a chance to "upload a copy of my birth certificate". 'Probably a good thing. There might have been an explosion.)













The children of most of our Post 604 VFW members would be covered by the "grandfathered" (in most ways the better) pre-July 2011 CDV/Remission of Fees program.

CDV/Remission of Fees applies only to the following schools: Ball State; Indiana State University; all campuses of Indiana University, Purdue University, Indiana University - Purdue University, and Ivy Tech Community College; University of Southern Indiana; Vincennes University; and Western Governor's University (WGU) INDIANA. ❖
