#### **Too Many Appeals**

On 15 September 2016 the US House of Representatives passed legislation to reform the Department of Veterans Affairs appeal process. "The American Legion organized a call to action . . in support of reforming the disability appeals process, though the organization didn't advocate for one bill over the other [Senate or House]. At the gathering, a handful of lawmakers stressed the current process was 'outdated,' 'over-complicated' and 'broken.'

According to the latest data from the VA, more than 450,000 appeals are pending, and veterans are waiting an average of three years to hear a decision.

If the process were to remain unchanged, the number of pending claims would jump to 2.17 million by 2027, the VA estimated. At that time, veterans would wait an average of 10 years to hear a decision on their appeals, said Rep. Dina Titus, D-Nevada.

'As VA continues to make progress aimed at ensuring that the best interests of veterans are the center of its focus, reforming the current appeals reform is yet another strong step in this direction,' the VA said in a statement earlier this week.

Many of the lawmakers who attended the news conference said their staffs answered calls every day from veterans who were experiencing long delays, some lasting years, awaiting a final decision on their appeals."

Your VFW Post 604 Service Officer says, "Not so fast, VA and Congress!"

#### **Overview**

The VA toll-free representatives say the current average wait time for an appeal hearing is 576 days. Two of the widows I'm trying to help have each been waiting over two and a half years for their first hearing, and they need the money.

Perhaps you saw the Herald-Times Sunday newspaper with Larry Bruce on the first page. Larry finally won his VA appeal at the United States Court of Appeals for Veterans Claims level. Eleven years and eleven months after his compensation claim was filed in February 2005. We are waiting on his C&P exam and percentage determination now. Larry's wife shared his financial hardship for years after he filed his claim. She passed away two years ago. Retroactive compensation [without interest, by the way] cannot buy back years of financial hardship, nor retroactively ease her stress as she and Larry skimped to pay their mobile home utilities bills.

You may also recall when the VA claimed great success in meeting Shinseki's [unrealistic] goal of a medical appointment within 14 days of a veteran's contacting the VA? While in reality veterans were literally dying after waiting months? Now appellants are dying before receiving their appeal decisions. VA medical centers, pension centers, and regional offices are amazingly successful at reporting 'good' data to Central Office.

Managers get bonuses that way. 'Unless the Central Office wants 'bad' data to support getting what they want from Congress. In those situations, the same offices are equally successful at reporting 'bad' data. E.g., "If . . unchanged . . by 2027, the VA estimated . . the veterans would wait an average of 10 years to hear a decision on their appeals." Translated: the VA wants Congress to give them an easy way out from under their self-created appeals backlog, which now stands at more than 425,000.

#### **Veterans Affairs Proposed Changes**

VA proposals to change the current appeals process include reducing the levels of appeal a veteran may choose to access. Example: 'If you choose the Decision Review Officer level, your appeal cannot go higher than the Regional Office level. If you start at the Regional Office level, your appeal cannot go higher than the Board of Veterans Appeals (BVA) level. (This is my personal interpretation of one option. However, the VA is apparently open to anything that is less burdensome than the current appeals process.) Another proposal is a limit of one appeal per claim. (I believe this means no re-opening(s) based on provision of germane, not previously considered evidence.) Another is the veteran could no longer provide any additional evidence after a designated level of appeal.

#### Not so Quick

But wait! The present system, as complex as it may be in some cases, has worked for decades to resolve problem cases, set precedents to be followed by initial claims adjudicators and thereby avoid appeals on the same issue, and protect veterans rights. The appeal levels and authorities are established and understood by service organizations, representatives, and the veterans themselves. The current system has established a wealth of 'case law' which may be searched online or in law school libraries. A radically modified appeals process might break the chain of interpretive clarifications, or at a minimum render the portions pertaining to appeals procedures and precedents obsolete.

### What Were the Most Recent Changes to 'Fix' the VA Appeals Process?

The Decision Review Officer (DRO) level of appeal was added in 2001 as an elective option in an effort to 'streamline' the appeals process by shortstopping the most easily fixed, straightforward appeals. If it worked, it must not have been much. Different regional offices used the DROs in different ways. Some were actually very helpful and did resolve appeals. Others were used as 'appeals development officers' preparatory to higher levels and did not try to resolve cases themselves. The VA Central Office was lacking in implementation guidance to regional offices, oversight control, and standardized training for DROs as shown by a Government Accountability Office study.

Next month, the United States Court of Appeals for Veterans Claims AND a seemingly magic way to drastically cut the number of appeals!
