While I was there I was struck by a carving on one of the walls; a-quote taken from Roosevelt's "Date that will Live in Infamy" speech. The quote on the wall read:

# New! Improved! Department of Veterans Affairs Non-service Connected Survivors' Pension!

I forget the exact year, it was somewhere around 1978. The Veterans Administration, as the agency was then called, proposed legislation that was adopted as a House Resolution, later passed by Congress and the Senate, and ultimately signed into law by the President. I am not kidding about the title of the pension law – they really called it the "new, improved pension". 'Sounded like dishwashing soap. Regardless of program limitations, it's all the VA pension there is these days for the surviving spouse of a wartime service veteran who passes away due to other than service connected causes. I've told my wife, Polly, that I hope she never draws anything under this program – although there are many surviving spouses out there who should and are missing out on possibly significant benefits. Especially under a little known medical expenses adjustment. Let me explain.

First, only unremarried surviving spouses of deceased wartime veterans have basic eligibility. "Unremarried" means that if first husband, honorably discharged WWII veteran Joe, passed away in March 2010 and widow Jenny remarried in June, she might be eligible for some benefits for the period between the first of April and the date she remarried. If second husband, non-veteran slime Alfonso, and she are divorced in July, Sue can reapply for resumed pension. "Wartime" is more liberal than it seems. The VA defines their own beginning and ending dates of wars and other eligible conflicts. Often the ending dates are well after most of the actual firing stopped. For example, a veteran who served only in 1954 would still be considered a Korean War Era veteran by the VA, even though the armistice was signed in 1953. There are some other eligibility details, like minimum period of military service and some borderline types of less-than-honorable discharges. The rule is: "When in doubt, apply."

Second, this pension program is what the VA diplomatically calls "needs-based". How much other income the basically eligible surviving spouse has determines how much, if any, VA pension she or he draws. That is the basis for my comment to my wife, "I hope you never draw non-service connected

pension." (To simplify pronouns, let's assume for the rest of this article that the surviving spouse is female, a widow.) If the Merry Widow, Polly A. Tilford, had more than a whopping \$7,933 in annual income, or \$661 per month, after Stupid John separated from active duty and then jay-walked in front of a UPS truck on the Square in late November 2010, she would have too much other income to draw pension. This is not a huge income we are talking about here. On the other hand, if Polly had absolutely zero other income, she would draw \$661 a month from the VA.

Which beats the heck out of nothing. The reduction for other income is dollar-for-dollar. The VA also considers net worth when establishing need, but they do not consider the value of the home in the net worth determination. (One-time insurance income might well have an effect on initial eligibility for drawing pension, as could last expenses paid by the widow on behalf of the veteran. Those are usually only factors the first year after the veteran's death.) The pension program is set up to help the surviving spouses the most who need the help the most. It just doesn't help a whole lot. (By the way, if Stupid John was killed, with no misconduct involved, before leaving active duty or as a delayed result of active duty causes, Polly would be covered by VA Dependency Indemnity Compensation (DIC). DIC benefit amounts have nothing whatsoever to do with other income or net worth.)

Third (and now things get complex, but potentially very helpful), there are categories. Polly is healthy. The dollar limitation for a Housebound (HB) widow is \$9,696 per year. Housebound means, generally speaking, that the person is medically prevented from getting out of their home very much. Trips to the doctor, drugstore, and to shop for food are to be expected. (Going bowling is not. Tennis is definitely out. Playing basketball, in Indiana, in March, well . . is probably not wise.) Most housebound cases are obvious, such as the person needs a walker to get around, or are on oxygen, or have limited mobility for any documented medical reason. The highest



I looked at that quote and thought to myself, "What about the 'So help us God' part of his speech?" I snapped a picture and resolved to look it up when I got back home. But I didn't.

Some time later I received the first version of an e-mail claiming the existence of a government conspiracy to remove "so help us God" from that carving on the wall; yet another attempt by persons unknown to rub out all traces of religion in America. I was all fired up because I knew I had taken notice of the wall and had my own photo (that I immediately dug up from my files) that seemed to prove the conspiracy. I do love a good conspiracy!

But then I did some research and found the conspiracy claims are, at best, overblown. If you read Roosevelt's speech or listen to a recording of it:

you'll realize, as I did, that what's on the wall is pretty darned accurate. It turns out Roosevelt wrote two paragraphs that are very similar. The one carved into the World War II Memorial wall is pretty much the way he delivered it.

Of course, the e-mails have never stopped. The same one keeps coming back around. Some people refuse to believe the evidence. My dad is one of 'em. He couldn't care less about the facts – he remembers it the way he wants to and he is convinced the words "so help us God" were rubbed out.

Don't get me wrong; I think it's a perfectly good question to ask why this particular passage was chosen for the wall rather than the much more remembered "so help us God" paragraph. Hey, I may still get a good dose of conspiracy out of this story yet. But that doesn't mean somebody took those words out of \*this\* paragraph. They were never there to begin with. So the next time you receive an e-mail from somebody screaming something from the highest hill on the Internet, take a moment to remember it might not be worth the paper it's not written on.

pension income category of the three is for widows requiring Aid and Attendance (A&A), that is, they require the "aid and attendance" of another person for their physical needs. You can figure it out. Requiring nursing home care results in an automatic A&A rating. The annual income limit for an A&A widow is \$12,681. Again, these limits are actually paid on a monthly basis. The VA needs a completed form signed by a medical doctor to certify HB or A&A.

Fourth (here is the most overlooked factor), medical expenses may be deducted from other income to initiate a VA recalculation of the pension amount. They have to exceed 5% of the annual limit and you have to take the initiative to report them. Given the fact that medical expenses can be real killers these days, this might well make a widow who would otherwise have far too much other income to draw pension become eligible for VA benefits. This is not a fun way to become eligible, but it beats having to choose between buying food and filling a prescription. A widow in any of the three categories described above can, each year, list the medical expenses she paid out of her own pocket on the reporting form and submit it to the VA. The VA Form to use is 21-8416A. Remember Polly, newly free and enjoying herself? Let's say her other income was \$1,000 per month from her cheapo husband's private survivor benefit plan. Her VA pension limit was \$661 a month. If Polly had a really rare form of fungus infection (from eating too many mushrooms) which required paying around \$600 per month for a drug to keep it under control, she could draw VA pension. The calculation is fairly simple, but the point is that the claimant does not have to do the figuring. They just turn in the medical expenses form. The VA does the calculation. Let's say Polly was denied pension due to "excess income" after John passed away in late November, 2010. She turns in her medical expenses a year later and the VA refigures her adjusted income, and retroactively pays her some pension back to December 1st, 2010 in a lump sum. If she continues to have about the same medical expenses for a couple of years or so, and the medical reasons for the expenses seem permanent, the VA will start assuming the same expenses at the start of each year, consider her medical expenses "recurrent", and pay accordingly. Everybody wins.

What are medical expenses? Doctor visits, hospital costs, lab fees, X-rays, and prescription drugs, of course. Premiums paid for private medical insurance, naturally. Don't forget the premiums paid for Medicare Part B paid by deduction from Social Security benefits. Now, stuff you didn't think of: bandages, pads, special food supplements, aspirin, Tums, sinus

sprays, Vicks, canes, Doctor Scholl's Foot Pads, corrective shoes, eye glasses, dental work, travel expenses to and from medical care – are you getting the idea? If it is legal, helps medically, the widow paid for it, and if push comes to shove her Doctor will give her a statement that she needs it, it's a countable medical expense for VA purposes. If in doubt, turn 'em all in. Let the VA sort 'em out.

You don't have to remember all of the above, just the important parts. Make sure any veteran's surviving spouse you know is aware of the basics: Veteran had wartime service, decent discharge, legal marriage (even recognized "common law" marriage), surviving spouse not currently remarried, submit doctors statement for HB or A&A, income either within limits (which usually raise every December 1<sup>st</sup>) or adjustable by consideration of medical expenses to within limits. Net worth below \$80,000, not counting her home. When in doubt, encourage the widow to apply. If you are a wartime vet who doesn't plan on kicking off soon, fine. Just don't forget this program as your WWII widowed mother enters a nursing home.

If the program was very much better Polly might push me in front of the UPS truck. But, if caught in the act, remember the Department of Veterans Affairs DOES NOT pay survivors' pension benefits to those who do away with their veteran spouses. (I thought it important to include that last bit of information.)

#### **VA Removes Online Signature Requirements**

The VA has removed the signature requirement for veterans who electronically submit an online 10-10EZ "Application for Health Benefits." The initiative will reduce the time it takes to evaluate online applications "by days, if not weeks," said VA Secretary Eric Shinseki. Previously, veterans filling out online applications were required to print a copy, sign it, then mail it. #### Stop-Loss Vets to Lose Retroactive Payments


Approximately 145,000 service members who were stop-lossed between 11 September 2001 and 30 September 2009 are eligible to receive \$500 for every month they were kept beyond their initial separation date. The problem is only about 20 percent, or 30,000 claims, have been paid, and the program ends 21 October 2010. The VFW is asking its members, Posts and friends to spread the word.
