## Some “This is no bull Stories

23 June 2014 issue, Army Times, page 19: Article title, “*Army tests Colombian-made mine boots*”. (Mine boots are designed to be worn while walking in an area suspected of being mined. The idea is to limit the damage to the wearer’s foot/feet when the mine explodes.) Now the good part, the sub-title: “*Guardsmen, Marines hired for wear trials*”. (I’m not making this up.) About half the way through the article we read, “*As part of the test, the Army hired three Army National Guard soldiers and three Marine Corps Reservists to test the boots for 20 hours over five days. The troops, employed as contractors, wore the boots through an obstacle course and a military operations in urban terrain course. . . . Factors used to evaluate the boots included improved blast protection, minimal additional weight and size . . . The testing showed that the boots are not ready for fielding, but the data collected will be beneficial for future research, officials said.*” Anything I would add now would be superfluous.

On a less macabre note, let’s consider two appeals of VA Milwaukee Pension Center denials of dependency indemnity compensation, one resolved in the widow’s favor, one just getting started: I didn’t pick up on this during the first appeal, but it is now evident as we start the second that the VA Milwaukee (yes, in Wisconsin) Pension Center which covers Wisconsin, Michigan, Iowa, Illinois, Indiana, Ohio, Missouri, Kentucky, Arkansas, Tennessee, Louisiana, Mississippi, and Alabama has been adjudicating DIC claims without having the veterans’ claim folders. Restated, the Pension Center has turned down widows for DIC benefits based only on the information in the VA’s frequently problematic electronic records. The deceased veterans’ actual claims folders are located either in the VA regional office which supported the veteran during his or her lifetime or in a federal records storage facility. All well and good IF everything in the physical claim folders had been scanned and input into the electronic records. It hasn’t.

In the first appeal case it was obvious to the widow, me, and anyone else with half a brain (actually, she had a full brain) that the Vietnam veteran had died due to Agent Orange presumptively service connected disabilities. He had both severe diabetes and ischemic heart problems AND was one of the terminally unlucky few whose liver could not tolerate his medication for the diabetes. In short, his death was about two and a half ways service connected. We filled out the VA Form 9 (formal appeal form) politely pointing this out and asked for a hearing. (Which brings up another issue, where? Milwaukee? We asked for Indianapolis.) I told the widow to expect a wait of several months for a hearing date. Meanwhile, she and I were to gather medical statements from her late husband’s doctors, scientific papers about the side effects of the diabetes medication, etc. The Pension Center capitulated without even a hearing and with no additional evidence submitted at all. They had just missed what would have been obvious to any VA adjudicator who had the veterans file. They granted the appeal and paid the DIC.

The second appeal is just getting started, but is already illustrating this same Pension Center systemic “only incomplete electronic file information available” problem. This deceased veteran was rated 100% service connected disabled for over nine years and ten months, just weeks short of the ten years required for his wife to draw the DIC regardless of the cause of his death. Any decent VA adjudicator in the old paper days would have naturally flipped back through the veteran’s file to around ten years before, looking for any excuse to make the 100% effective date earlier. Well, the Pension Center adjudicator didn’t have the paper file, AND the portion of the paper file which had been scanned into the electronic record only went back to 2007. Restated, the Pension Center adjudicator couldn’t look at the scanned documents from the 2004 and earlier portion of the veteran’s file, there were none. There was no way to look for some way to help the widow. Let’s hope that our requesting copies of the late veteran’s claim folder and VA medical records will turn up something. A lot of work/hassle/delay to search for information which should have been available to the VA adjudicator at the time of consideration of the widow’s claim.

So what can we take away from the above? 1) Don’t accept a contract to test anything to do with anti-personnel mines. 2) Don’t meekly accept a VA denial. Do your research and appeal if necessary. 3) The VA Pension Center has a pretty serious problem in considering only partial records when denying survivor benefits. (I’m certain no one will tell the new Secretary of the Department of Veterans Affairs about this. Therefore even more widows will be denied DIC based only on consideration of incomplete records. We’ll never know how many might have been awarded the benefit had the full veteran’s record been available.) 4) Don’t delay filing for your service connected disability, or to later ask for a reevaluation if appropriate. Had our second example veteran claimed his 100% just a few weeks earlier, all this records issue would be moot and his widow would be drawing DIC now.
