## Mamie-itis

I was a brand-new veteran's benefits counselor (VBC) GS-962-7 in 1975. Several Indianapolis Regional Office VBCs with years of experience helped train me. Mamie was one. Let's not worry about her last name, even though I'm sure she passed away decades ago.

Mamie was the widow of a WWII veteran. So was Helen Troy, mother of Mike Troy, double gold medal winner in the 1960 Rome Olympics in swimming. (Helen once stayed with Polly to help watch our two small children during one of my many Reserve annual trainings. I asked her to bring her gold medal to show us when she first stopped by the house. Mike had given her one of his two. Helen had raised two sons after her husband's passing. Mike thought she deserved it.) So that was the VA regional office workforce in the mid-1970s: a few remaining WWII veterans (You may recall an earlier article about Infantry Airborne Mel Biddle and his Medal of Honor), a group of WWII widows (Mamie, Helen), a group of Korean era veterans, a new wave of Vietnam veterans, and a few others who seemed out of place. (It would seem that these days the 'out of place' crowd has taken over the VA.)

Mamie had worked for the VA for decades and was still a GS-9, the full working level of a VBC. Most of us rotated between working in the 'toll-free' telephone area (which then consisted of a bunch of cubicles in a windowless area on the first floor with each 'cube' surrounding a VBC, a telephone with headset, a small library of reference materials, coffee or soft drink, and half-eaten snacks), the 'walk-in' area (regular office desks separated by screens near the walk-in entrance to the regional office – the receptionist's nick name was 'The Dragon Lady'), and upstairs on the third floor attached to an adjudication team to assist in perfecting claims (adjudicators were not supposed to contact claimants in person or by telephone). I noticed that Mamie spent more time on extra kinds of duties, such as answering correspondence and carrying special cases through processing, and less in actual contact with the veterans. The VA was a sort of folksy federal agency and took pride in protecting some employees. (This was in contrast to the IRS which I had just transferred from to return to Indiana. In the IRS you succeeded or were fired. Four years later I returned to the IRS.)

Mamie showed me how to research benefits questions, how to answer letters, the way to the nearby White Castle, and other critical things.

I suddenly realized one day, after about three years of working for the VA, how often Mamie cheerfully complained (not really complaining, sort of bragging) to anyone who would listen about how often her daily stack of cases included a real problem case, the kind that take hours to straighten out, that demanded dedicated time of a senior VA employee to coordinate corrective action, that resulted in other VA employees taking over the remainder of Mamie's stack of claim folders.

Now, to this day, I have the greatest respect for Mamie's dedication. She was also sharp regarding what needed to be done. She was fearless in asking managers to drop what they were doing to assign one of their adjudicators to work her current crisis case.

However, even as slow as I am, on that realization day I started to question how it could be that these disaster cases always seemed to be Mamie's. We all had problem cases. We all worked them. But she seemed to have them much more frequently than the rest of us and they always seemed more complex.

My conclusion was that Mamie was the 'carrier', sort of like, you know, Typhoid-Problem-Case Mamie. Mamie must have been

making an average of a case per day into a crisis case. Maybe it was her way of displaying her expertise, maybe in pursuit of a good performance evaluation and/or performance award, maybe a way to get the rest of her workload assigned to others or delayed, or maybe working such cases made her feel important.

But nobody – nooooo-body – could be that unlucky.

Since that time I've recognized other Mamies in other offices. At times I've started down that path and, with sudden and embarrassing recognition, caught myself. At other times I've been in a position to talk to other 'Mamies' (including one First Sergeant) about their work. The speech goes something like this, "Yes, that (veteran, taxpayer, customer, soldier) is really lucky to have you dedicating all your effort to correcting their problem, no matter how long it takes or how difficult it is. You are a real bulldog, and an expert one at that. However, have you considered how unlucky are the other (claimants, taxpayers, customers, soldiers) for whom you are responsible and who are having their cases delayed while you work only on that one problem case? Maybe their cases are simple and could be fixed quickly. Maybe their problems are even more severe and need attention as soon as possible. Assess your workload. Determine how difficult the cases are and how time critical. Get the serious cases to those who can get them done. Sure, include yourself. Either quickly crank out the simple ones or give them to the new employees for training. Don't – for whatever reason – cheat the lower people in the stack because you get hung up on one case. Routine cases become problem cases with age."

Well, here we are, waiting with widows and veterans for years for their VA appeal cases to be resolved. I wonder if the 'Spirit of Mamie' lives on.
