## You got paid for travel to the VA med center? And I didn't?

A member asked if I could clarify the eligibility criteria for travel pay from Bloomington to the VA medical center on West 10<sup>th</sup> Street, Indianapolis. He knew other veterans, seemingly in similar situations, were paid and some weren't. My answer was, "No, I can't. But I'll try to find out."

There may no longer be visible travel pay people by the pharmacy, but there's still a travel pay function. I finally got through to the VAMC travel pay office at 317 988-2510. The travel pay supervisor, Laura, answered. Laura confirmed the current reimbursement rate at 41.5¢ per mile and also confirmed information on the VA "Beneficiary Travel" page at [www.va.gov/HealthBenefits/vtp/Beneficiary\\_Travel.asp](http://www.va.gov/HealthBenefits/vtp/Beneficiary_Travel.asp) which showed the following:

### You Qualify If:

- you have a service-connected (SC) rating of 30 percent or more, or
- you are traveling for treatment of a SC condition regardless of percentage rating, or
- you receive a VA pension, or your income does not exceed the maximum annual VA pension rate, or
- your income does not exceed the maximum annual VA pension rate, or
- you are traveling for a scheduled compensation or pension [This probably refers to a 'C&P' exam in conjunction with an initial claim] - See more at: [www.va.gov/HealthBenefits/vtp/Beneficiary\\_Travel.asp#sthash.iXPmqODO.dpuf](http://www.va.gov/HealthBenefits/vtp/Beneficiary_Travel.asp#sthash.iXPmqODO.dpuf)

### You Qualify For Special Mode Transportation If

(Ambulance, Wheelchair Van etc.): - See more at: [http://www.va.gov/HealthBenefits/vtp/Beneficiary\\_Travel.asp#sthash.aDfETM7l.dpuf](http://www.va.gov/HealthBenefits/vtp/Beneficiary_Travel.asp#sthash.aDfETM7l.dpuf)

- you meet one of the 'You qualify if' basic eligibility criteria, and
- your medical condition requires an ambulance or a specially equipped van as determined by a VA clinician, and
- the travel is pre-authorized (authorization is not required for emergencies if a delay would be hazardous to life or health)

The 'You qualify if' information' seemed pretty straight forward except for 'your income does not exceed the maximum annual VA pension rate' being repeated twice, having to guess what the last 'bullet' was intended to say, and not telling the reader how to find out what 'maximum annual VA pension rate' really means: My best guess is the current 'without dependents' and 'with dependent' income limits at all three levels of non-service connected total disability pension; i.e.; basic, housebound, and aid & attendance. (These three levels can be roughly translated as 'unemployable', 'can only get out for medical appointments and necessities', and 'should be in a nursing home'. The most severe two can be claimed via a VA Form 21-2680.)

How does a veteran get qualified for travel pay if his or her income is the same or less than the appropriate limit? - by submitting VA Form 1010EZR, which is available online at <https://www.1010ez.med.va.gov>, at their local VA medical center or clinic, or by contacting 1-877-222-VETS (8387) to have the form mailed. Pension countable income adjustments used for pension claims – such as unreimbursed medical expenses – also apply when the VA determines countable income for travel pay purposes.

There is a deductible for VA travel pay of \$3.00 one-way (\$6.00 for round trip). The deductible requirement is subject to a monthly cap of \$18. Upon reaching \$18 in deductibles or three round trips, whichever comes first, in a calendar month travel payments for the balance of that month will not be reduced by the deductible.

Apply for travel reimbursement by completing [VA Form 10-3542](#) (Veteran/Beneficiary Claim for Reimbursement of Travel Expenses) and, within 30 calendar days from the date the travel is completed by -

- Visiting the Beneficiary Travel Office after completing an appointment, or
- Calling the Beneficiary Travel Office (this method will require an added step to complete and sign the travel reimbursement form), or
- Sending the travel reimbursement form via either secure fax or mail to the Beneficiary
- Or by just asking the VA employee about travel pay at the reception desk of the VAMC area where you just completed your appointment. He or she might say, "Sure! Please sign the electronic signature pad!" Laura went on to say that a unique tracking number appearing on the screen immediately after your 'Sign this electronic sensor pad' entry confirms the travel pay has been successfully requested.

Maybe some of those veterans who did not get paid forgot to apply or ask.

Here's a comment from a VAMC employee who reviewed this article: "I would also add something that is often overlooked, if veterans are not subscribed to the direct deposit or direct express debit card process we could be sending a check to an outdated address if they have not updated their address with our fiscal office. Unfortunately our financial system and our registration system do not update each other and thus a very manual reconciliation process happens regularly when we receive returned checks. If at all possible I would appreciate you adding in the direct deposit process in this write up as some veterans may have been paid but the check came back to us in finance and we have not been able to track those patients down as of yet to get the payment to the correct address. I have attached the pamphlet we send to those we are in contact with and it offers more information which will benefit all of your prospective readers."
