## Money

Sometimes the obvious can surprise us. We all know that unscrupulous people will do just about anything to make money; steal, defraud, scam, etc. If there's a loophole in the law and gullible people to use – you get the idea. "A sucker is born every minute" and "Nobody ever went broke overestimating the intelligence of the American consumer" are statements too true for comfort.

On another (but unfortunately overlapping) realm, honest business men and women will also offer to fill just about any need to make money. They and/or their stockholders have to make a living/profit. If there's a marketable service which is not specifically barred by law and potential customers who are willing to listen to a sales pitch – here we are again. 'Hard for you and me to tell the difference. Maybe there isn't any real difference, just a question of degrees.

Last month our Quartermaster was approached by a private law firm offering to represent any veteran who had been exposed to asbestos while on active duty and who was later diagnosed with mesothelioma. The firm cited wide experience, a great success rate, and – maybe – no cost to the veteran client! They wanted Mark to insert a brief advertisement for their service in the Post 604 newsletter. I'd guess the same request went to every VFW, American Legion, DAV post (and every other military service organization or club or society they could think of) in the country. They want free advertising. You'll notice Mark did not place their ad in this newsletter.

If any veteran has been diagnosed with mesothelioma and there is any reasonable chance of exposure to asbestos while on active duty, he or she should certainly file a service connected disability claim with the Department of Veterans Affairs. Any veteran with any permanent disability which can be reasonably established as having been caused or aggravated by military service should. If not for themselves, for their dependents. Assisting in the application and potential appeal processes really is a service. That service can be provided by a VA-approved attorney of the claimants' choice, by a VA accredited claims agent, by any military service organization Service Officer, by a representative at the Indianapolis VA regional office walk-in area on the

third floor of the Minton-Capehart Federal Building or over the telephone (if the call goes through), by any Indiana county Veterans Service Officer or assistant, or by your smart pre-law college sophomore niece. All are totally free. (With the possible exception of the niece.)

Or, veteran Jones could answer an advertisement and sign a contract with a business. Businesses exist to make money. Maybe it's a slice off the top of any back compensation. Maybe it's a fully and honestly admitted, up-front charge. Maybe the source is initially not mentioned, such as in the Aid & Attendance scams wherein completion of the VA pension claim forms is free but there are filing charges, administrative charges, mailing charges, and – worst of all – totally hidden kick-backs to the local scammer by the 'financial management' firms who cheerfully accept the veteran's money (which must be removed from the claimant's net worth to meet the asset test) and invest it in funds they administer primarily for their own profit. All these are legal. That does not make them good choices.

There are good attorneys in Bloomington. Mike Carmin and Angela Parker have both helped me, for examples. Most of the good ones do not advertise loudly on the telly and radio or hold 'seminars' with red, white and blue sales brochures in retirement living facilities. They don't have to. There are also crook attorneys in Bloomington who do highly visible public service things in order to look good. When I say 'crook' I do not mean illegal. I mean they are out first to make as much money as possible and second to help the veteran. But only if the second does not interfere with the first. In some cases, the crooks have been known to charge research fees to obtain critical documents, determine they aren't going to make enough profit from filing the claim, and throw the entire case file in the trash.

At least start with either the county Veterans Affairs office or your military organization's service officer. You don't sign a binding financial contract with us.
